Duties & Responsibilities

The Pharmacist duties shall include, but are not limited to the following requirements:

- a. Review and verify prescription/medication order(s) from the Pharmacist-in-Charge, CEO/CME, or other authorized prescribers for completeness, correctness, authenticity and legality;
- b. Assess prescription/medication order(s) against patient's/youth's medical profile for improper drug selection, under-dosage, dosage, over-dosage, drug interactions, dosage form and delivery system;
- c. Assess prescription against Formulary for compliance, and refer non-formulary requests as required for approval when necessary;
- d. Manage or directly perform computer order entry and type prescription labels;
- e. As required by the Pharmacist-in-Charge, assist in the preparation of estimates for the requisition of drugs required;
- f. Monitor and instruct Pharmacy Technicians in standard and routine phases of the work, as appropriate;
