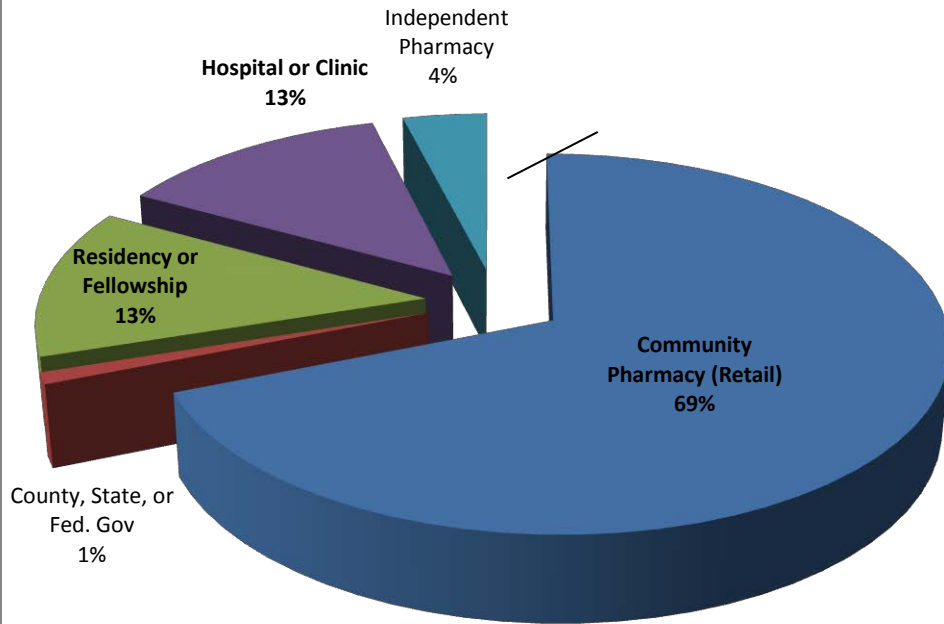

Employment as a pharmacist is based on successful completion of the licensure exams. The survey is administered to graduating students and within six months of graduation to allow for the examination and receipt of successful completion of the licensure requirement. Contact with the graduate by employers, University employees, and program preceptors. Also includes survey response updates for students who indicate "seeking employment" on the initial survey and later obtain employment.

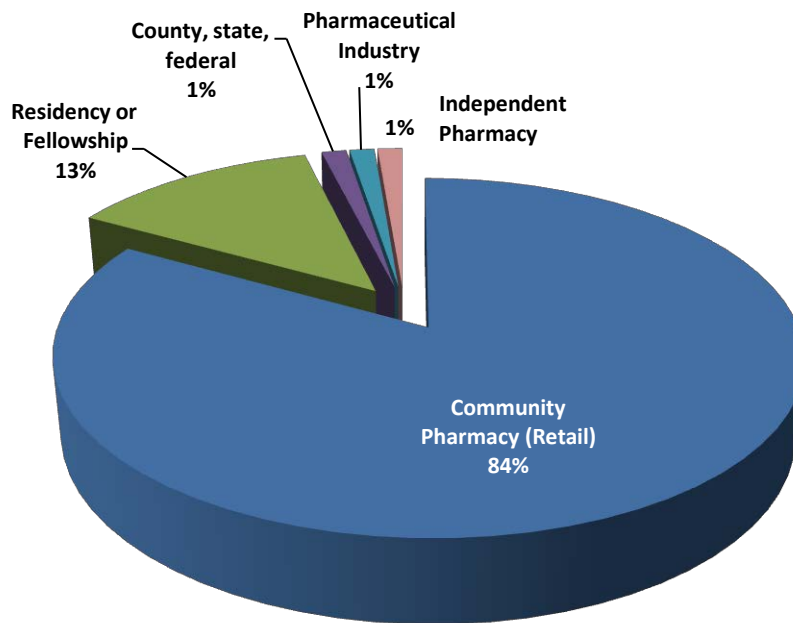

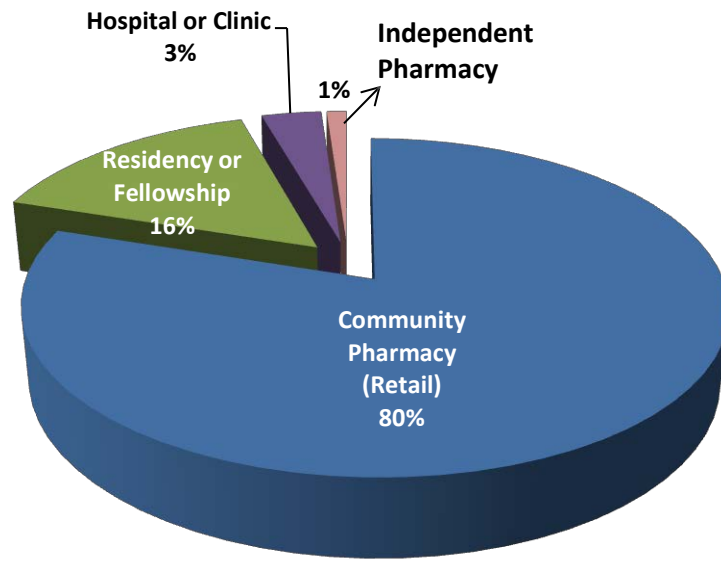
**Graduate Employment Data by Category - Class of 2012**



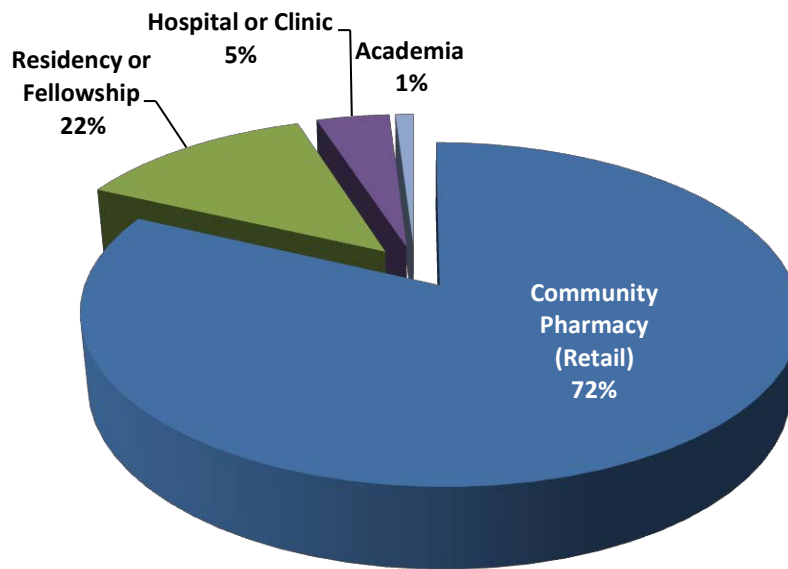
**Graduate Employment Data by Category - Class of 2013**



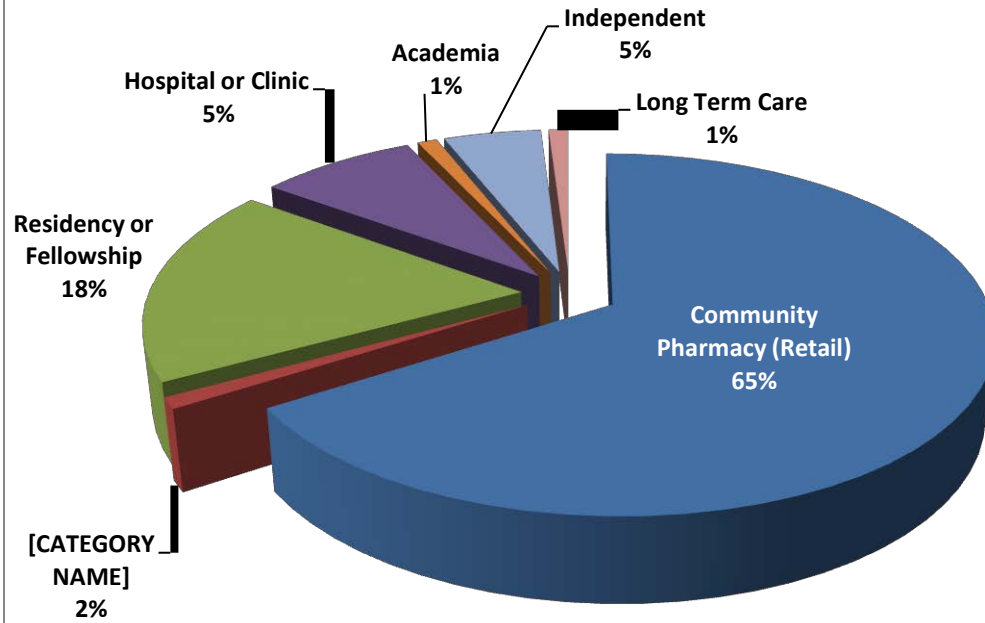
**Graduate Employment Data by Category - Class of 2014**
